In July 2025, the European Commission presented its proposal for the next Multiannual Financial Framework (MFF) post-2027, including the Framework Programme for Research and Innovation (FP10) 2028-2034, the successor to Horizon Europe, with a proposed budget of €175 billion. The programme is designed to work in close synergy with the proposed European Competitiveness Fund (ECF), aiming to strengthen the Union's technological leadership and global competitiveness. This coordinated approach seeks to support the full cycle of investment – from research and development to market uptake.

How will the close integration between Horizon Europe and the ECF affect the future funding landscape? What implications will this coordination have for the governance and implementation of Horizon Europe? How can the future framework strike the right balance between excellence-driven research, industrial competitiveness, and strategic policy priorities? What novelties and changes can be expected in the next programming period?

Against this backdrop, the GIURI Annual Event 2025 will provide an opportunity to explore these questions at an important stage in the policy process. By bringing together policymakers, experts, and stakeholders, the event will offer a platform for in-depth discussion of the Commission's proposal and its main elements, shedding light on the key components of the next EU Framework Programme for R&I and the Competitiveness Fund.
